



2024 FEE SCHEDULE

CKC offers flex scheduling to accommodate individual family schedules. The registration fee and the first week’s tuition are due upon enrollment. Schedules for the following week are due every Wednesday, invoices are sent every Thursday, and payment is due every Friday. Cash or cheques can be dropped off in the payment lockboxes. Credit card or bank transfer payments can be made directly through the childcare management. Wisconsin Shares funding is accepted. Refunds are not provided for absences on scheduled attendance days. All fees are non-refundable and non-transferable. All fees are subject to change at the discretion of the Crossroads leadership team for any reason at any time.

Full-time enrollment is 3 days a week for all children except school-agers. Full-time enrollment for children in kindergarten or older is 2 days a week. Full-time enrollment requires the minimum day charge each week, even if care is not needed. When a child turns 3 years old, they will be charged the Two’s rate until the preschool teacher confirms they are fully potty trained. Drop-in rates apply to attendance that is less than the minimum days per week. The hourly charge applies for attendance of less than 5 hours a day, exceeding 10 hours per day, early drop-offs, and late pick-ups exceeding 30 minutes outside the scheduled times provided.

4K and school-age children may unenroll during summer months and re-enroll for the school year. Parents who are educators receive a 1-day minimum during full non-school weeks. The transition billing procedure from 4K to School-Age (once the school year ends) is as follows: four-year-olds not attending 4K will remain under the Fours’ billing rate; 4K graduates who are four years old will stay under the 4K billing rate; 4K graduates who are five years old will move to the school-age billing rate.

Initial Registration Fee (<i>once</i>)	\$125 for the first child and \$62.50 for each additional child due at enrollment.
Material Fee (<i>annually</i>)	\$62.50 per child recurs annually in September (<i>only drop-in children are exempt</i>).
Late Schedule or Change Fee (<i>situationally</i>)	\$15 for schedule changes submitted after noon on Wednesdays.
Late Payment Fee (<i>situationally</i>)	\$15 fee for payments made a week or more after the due date and is added weekly.
After Hours Pick-up (<i>situationally</i>)	\$1 fee per minute per child for late pick-up after 6:00pm paid directly to the teacher present.
Hourly Rate (<i>situationally & drop-in</i>)	\$15 per hour for scheduled days (<i>under 5 hours, over 10 hours, early drop-off, late pick-up</i>).
